NDT of steel wire rope

Conducting non-destructive testing (NDT) of steel wire ropes is a critical procedure for ensuring the safety and reliability of various systems, including marine cranes, cableways and bridge tension cables.

This method allows you to identify defects and damage that could go unnoticed during visual inspection.



Dropped object survey

This survey is an analysis to identify what happens to the facility and personnel safety if items are dropped. Dropped objects are those items with the potential to fall from their static position under their own weight. If the lost object results in an event or accident, structures should be adequately protected to absorb the impact energy.

Dropped objects represent a significant safety and operational challenge to any asset owner or operator particularly at onshore and offshore rigs.

























